# **Spring Bulletin**

Spring is here with a vengeance and there will be projects on the river starting before you know it. Right now a bunch of folks are clearing roads and sections of rivers thanks to the March Lion that rolled through the region a few weeks ago.

The goal of this bulletin is to provide you with a comprehensive list of projects going on throughout the watershed in 2012. It allows for organizations still planning events to avoid busy times so they can count on a good turnout. It helps potential volunteers to "plan out their dance card" over the next few months in order to tailor service to the river with the other demands of life.

Undoubtedly we won't have all the projects going on this year listed. There are others yet to be determined. In light of that, expect to see an update or two this season. In the future, the Au Sable River Watershed Committee (AWC) will have its own website where folks can go to get the latest on projects and events. This year we just have to use email and snail mail.

In addition to schedules there are two other things I want to bring to your attention.

The first is the initiation of a tree removal fund. The unprecedented level of downed trees this spring has really stretched the resources of entities such as Huron Pines – they have played a huge role in tree removal over the years – to address it. The AWC Executive Committee has earmarked \$3000 this year to help pay for the service. Much more is needed going forward. A level of \$10,000 has been suggested. Most years much less than that will be spent. Huron Pines has agreed to be the agency that will handle this crucial service. They have ample experience. We do need to raise the monies and are hoping that organizations and individuals would consider donating to this fund. Many of you have received a letter specifically addressing this issue.

The second thing I wanted to address involves an effort to study brown trout migration patterns on the Au Sable that will start this May. Anglers of the Au Sable, Grand Valley State and the DNR Fisheries Division are teaming up to do this project. The results could produce huge dividends for fisheries management in the future – see an article about it in the latest issue of *The RIVERWATCH*. While costly, money is not the major concern. The project needs dozens of volunteers. Twice a week each section, North, South, and Main, must be floated in order to locate the trout. We probably need at least 30 volunteers per section so nobody gets burned out. If you are interested in participating please contact Steve Sendek at sendeks@michigan.gov.
